1. Last date of filling of Nomination Form – 19th April'2023, Wednesday before 5.30pm
2. Date and place of scrutiny of Nomination Form – 24th April'2023 (Monday) at 5.30pm at Chapter's office, C G Road, Navrangpura, Ahmedabad.
3. Date of withdrawal of Nomination Form – 1st May'2023 (Monday) before 5.30pm
4. Date of Polling – 9th May'2023 (Tuesday), Time : 8.00am to 7.00pm at Chapter Office
5. Date of Counting – 9th May'2023 (Tuesday) after 7.00pm
6. Date of Declaration of Result – 9th May'2023 (Tuesday) after completion of counting
7. No. of Members to be elected – 9 (Nine) + 1 Student

Gist of new chapter Bye Laws for contesting the election:

1. List of voters is available on chapter website (www.ahmedabadicmai.in) who is eligible to contest the election / to cast his/her vote.
2. Fees for Election: A candidate for election has to pay a nomination fee : RS 1000/- +18% GST.
3. The fees shall be paid by Cheque / Pay order / DD / NEFT in favour of "The Institute of Cost Accountants of India - Ahmedabad Chapter".
